### **Fisk Jubilee Singers sheet music folio**

The Fisk Jubilee Singers were a group of African American singers at Fisk University in Tennessee who sang spirituals and other American songs. The first incarnation of the ensemble came together in 1871, but the group still sings today. The cover of this sheet music folio lists seven songs, including "The Gospel Train" and "Swing Low Sweet Chariot." The Fisk Jubilee Singers launched the jubilee singing tradition, which grew in popularity through the first half of the twentieth century. Early jubilee singing ensembles adhered closely to the style of the Fisk Jubilee Singers, performing religious songs in close harmonies. As time went on, many jubilee groups branched out to perform popular, non-religious music.

## Public Domain

Public Domain is a copyright term that is often used when talking about copyright for creative works. Under U.S. copyright law, individual items that are in the public domain are items that are no longer protected by copyright law. This means that

you do not need to request permission to re-use, re-publish or even change a copy of the item. Items enter the public domain under U.S. copyright law for a number of reasons: the original copyright may have expired; the item was created by the U.S. Federal Government or other governmental entity that views the things it creates as in the public domain; the work was never protected by copyright for some other reason related to how it was produced (for example, it was a speech that wasn't written down or recorded); or the work doesn't have enough originality to make it eligible for copyright protection.
